#### Directions to the School from I 90

Take the Three Forks Exit # 278 and head North (right coming from the Bozeman) Take the first left and follow the detour signs (this includes a left turn 0.4 miles into the detour) At the end of the detour turn right toward Three Forks. Coming from the West turn right off of exit 278 and stay right onto Montana Highway 2 into Three Forks. You will see the school on your left. Turn left on 2<sup>nd</sup> Ave E or on Neal. Please leave the areas in front of the school for prop loading and unloading. There is a parking lot across the street from the school and in back of the school. Additional parking is on the side streets and at the end of the elementary school.
